Anne Arundel County

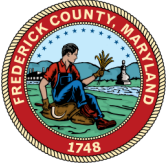

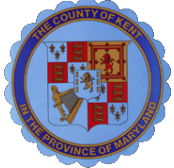
Packing has begun for our move back to Calvert Street. We hope to be in and settled by the first of the year.
